Identifying and Addressing Needs Across the Region

At the EDA University Center Showcase this past April we discussed ways to provide better technical assistance across our respective states. This involved a series of workshops: identifying and addressing needs across the region, leveraging EDA dollars, and measuring impacts of provided technical assistance. Over the coming months we will address each of these topics in the newsletter to make you aware of what we are doing to better serve the state of Minnesota.

One important consideration when providing technical assistance is how do we identify and address needs across the region? While I am not sure where I first heard it, I have often said "We don't know what we don't know". As assistance providers, we have an idea of what we think others need. We can come in, observe an organization and see something that may be of value to the organization. This does not always match the wants or goals of the organization with whom we are working. To make sure we adequately address the needs of organizations, we must incorporate what the organization actually needs/wants with our perceptions of what is beneficial to the organization.

This process begins with a request from an organization with explicit description of their needs and wants. On our website, we have a link to a document that can be completed and sent in to us (http://www.edacenter.org/downloads/EDA_RFA_Form.pdf) or the request can be completed and submitted online (http://www.edacenter.org/technicalAssistance_request.php). Once we receive this request, we will work with the submitting organization to determine how we can

assist. There are some improvements that can be made to this process. Not everyone is aware of how to request technical assistance or think their needs do not fall within our expertise. As a result, there are people we could be assisting that are marginalized. If we could reach these people, we could make a better use of resources The EDA Center has to offer.

An initiative we are involved in aims to address this very topic. The staff of The EDA Center at the University of Minnesota Crookston along with two representatives from MADO (Cheryl Lee Hills and Nicole Griensewic) are taking part in the Great Lakes Training Initiative. This initiative includes the EDA University Centers from five states (Indiana, Michigan, Minnesota, Ohio, and Wisconsin), rural, and urban economic development representatives who comprise an advisory board.

The purpose of this initiative is to look at how do we determine training needs? To answer this, we need to know what is currently being done and what needs still are unmet. For example, how can we recognize underutilized assets and make better use of them? The final piece we are working on is how can we effectively communicate with our stakeholders so they are aware of how we can help? Some examples we are working on is developing a website for the entire Great Lakes Region to use as a resource. This would also include frequent communication like newsletters. Look for more information as we continue this process and please contact us if you have any questions about our services.

REMINDER: EDA Federal Funding Opportunity for FY 2014-2105 Deadlines

Just a reminder to any organizations who may be interested: the U.S. Economic Development Administration (EDA) FY 2014 Economic Development Assistance Programs Federal Funding Opportunity deadlines are coming soon. The purpose of this FFO is to "support construction, non-construction, technical assistance, and revolving loan fund projects" as part of the EDA's Public Works and Economic Adjustment Assistance programs. "Grants made under these programs will leverage regional assets to

support implementation of regional economic development strategies designed to create jobs, leverage private capital, encourage economic development, and strengthen America's ability to compete in the global marketplace."

Eligible applicants include: private institutions of higher education, state governments, city or township governments, 501 (c) (3) and other nonprofits, Native American tribal governments, county governments, and other organizations listed in the grant

opportunity announcement. Applicants from rural and urban areas are welcome to apply. Deadlines for the next two funding cycles are:

- June 13, 2014 for FY 2014 funding cycle 4
- October 17, 2014 for FY 2015 funding cycle 1

Minnesota Exports \$20.7 Billion Worth of Goods in 2013

In the recent Annual Export Report, DEED values the amount of goods exported at \$20.7 billion for 2013. This is a \$106 million decrease from 2012, or approximately 0.5 percent recession. This ranks Minnesota 20th among all states in 2013. As shown in table 1, the top five countries remain the same as 2012: Canada (\$5.76 billion, -8%), China (2.46 billion, -1%), Mexico (\$1.47 billion, +14%), Japan (\$1.07 billion, -10%), and Germa-

ny (\$760 million, +4%).

While the growth in exports over the past year was lower than the U.S. average (2.1%), Minnesota is still exporting a near record amount in goods. More than 8,600 businesses in the state of Minnesota exported goods and services which helped generate approximately 136,900 jobs in Minnesota, 17th largest among all states (according to International Trade

Administration data). Of the jobs created, 65,100 jobs were in the manufacturing sector while 71,800 jobs were in sectors integral to delivering goods to market (such as marketing/sales, transportation, and logistics).

DEED Report: 2013-2014 Local Area Unemployment Statistics and Jobs Report

After seasonal adjustments, unemployment in April dropped to 6.3 percent in the U.S. and 4.7 percent in Minnesota. Minnesota unemployment claims in April dropped 2,959 to 17,153 when compared to March. Over the year unemployment claims decreased 16.1 percent when compared to April 2013.

Minnesota employers eliminated 4,200 jobs in April. Professional Manufacturing (2,400), Government (1,500), and Information (200) added

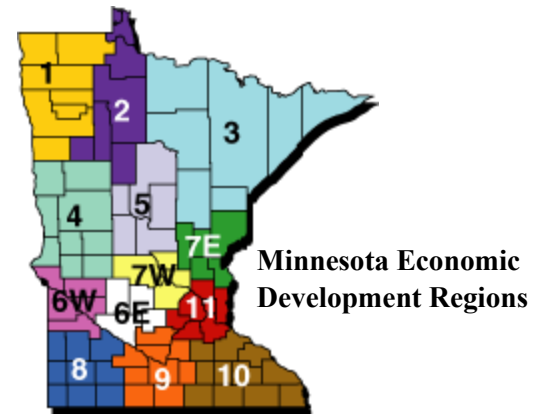
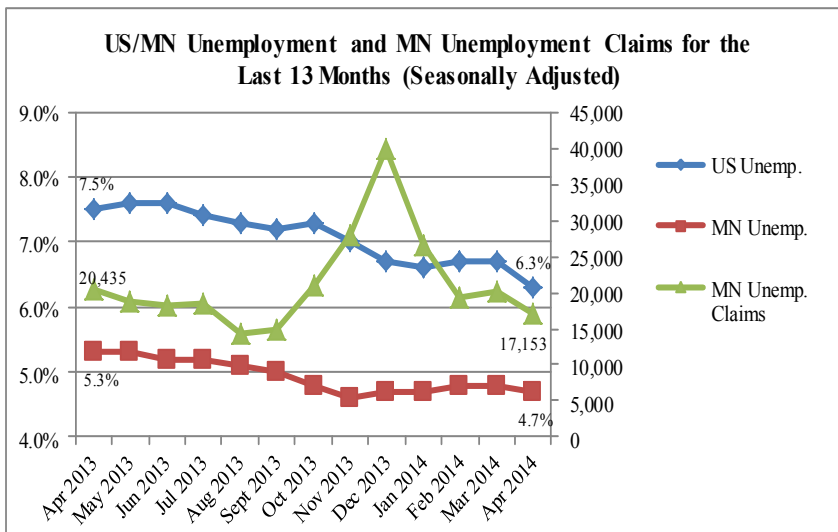
jobs in April. Professional/Business Services (-2,200), Construction (-2,200), Leisure/Hospitality (-1,700), Financial Activities (-800), Educational/Health Services (-700), Other Services (-600) and Mining/Logging (-100) posted job losses in April. Trade/Transportation/Utilities employment remained steady.

Minnesota has experienced 1.5 percent growth from 1 year ago with 41,934 additional jobs over the past year. This growth is below the U.S.

growth rate of 1.7 percent over the past 12 months.

April unemployment for all EDRs dropped when compared to March. The North Central region experienced the largest drop in unemployment at 1.8 percent.

Thriving by Design II: Achieving Rural-Urban Economic and Community Health, -Crookston July 30-31

Design is a process. It is a process by which designers create the physical artifacts that surround us in our daily lives and define our civilization. The results of the design process are meant to solve problems.

Yet, all of us have problems to solve, issues to address, or things to create. In this regard, we are all designers.

Designers have the benefit of formal training in the design process, allowing them a way of thinking that is best described as design thinking.

Design thinking:

- can be imagined as a method of applying *creativity to action*;
- seeks to identify creative and practical solutions to address specific issues and problems while attempting to achieve broader and holistic goals – an improved future condition;
- examines both present and future conditions, allowing simultaneous exploration of a problem and possible solutions; and
- can be applied to nearly any issue or problem.

Join us for a Rural Design Conference

to explore design thinking and practice, applying the technique to specific issues on the rural landscape: nature-based recreation, food systems, and the role of Extension.

The Rural Design Conference is titled **Thriving by Design II: Achieving Rural-Urban Economic and Community Health**, and it will be held **July 30-31, 2014 at the University of Minnesota Crookston.**

Who should attend: Community leaders, elected officials, and planners, especially those from rural and small urban areas, designers, and anyone interested in learning about the use of design and design thinking as a problem-solving opportunity.

What you will get out of the conference: You will gain experience in visualizing and using design to achieve, sustain, and strengthen community vitality across our region. By using design and design thinking techniques, you will help create, select, and frame ideas and goals that can inform Minnesota's community development.
